Subject: Amusement Tax Ordinance

The following are items to remember when filing your Amusement Tax return:

- Worksheets must be completed, or a computerized statement from the promoter must be attached.
- Payments are due by the 10th of the following month.
- The tax is based on the admission price, if the band or entertainer is paid from the cover charges the tax must be collected first and remitted.
- In order to qualify for a non-profit exemption the agency receiving the proceeds must file for the amusement permit. The total cover charge must be remitted to the non-profit organization to qualify for the exemption.
- Failure to comply with the Amusement Tax Ordinance will result in legal action brought against you by the City of Harrisburg, and the revocation of all licenses and permits issued for said business.
- There may be occasions that an agent from the Tax & Enforcement Office will conduct spot inspections to verify compliance with the law.
